The Best Lawyer's "One's to Watch" category recognizes attorneys practicing for less than ten years.

Dennis E. Westlind was recognized as 2023 *Best Lawyers* "Lawyer of the Year". He was recognized in the "Labor Law – Management" category. Only one lawyer in each practice area for a particular geographical region is named "Lawyer of the Year," which makes this a distinguishable honor. Receiving this accolade expresses the amount of respect a lawyer has amongst their peers regarding their abilities, professionalism, and integrity.

First published in 1983, <code>Best Lawyers®</code> has published their list for more than three decades and is regarded as the most reliable, unbiased source of legal referrals. Each year, attorneys are nominated by anyone but themselves for inclusion in <code>The Best Lawyers in America</code> listing. Primary sources for the nominations include clients, fellow lawyers, and marketing teams. Once nominations are collected, ballots are generated and distributed to listed lawyers who vote. Voters assess fellow lawyers on a numerical scale regarding how likely they would be to refer a case to the nominated lawyer if they weren't able to take the case themselves. Lastly, the <code>Best Lawyers</code> editorial staff reviews the votes. By executing this evaluation process, the <code>Best Lawyers</code> in <code>America</code> listings aim to accurately capture the consensus opinion of leading lawyers regarding their colleagues
