## Scope of Work:

Comparative Microwave Return Loss testing between the Bald Hill Microwave antenna system and the far end of that Microwave Link at Columbia Dispatch indicated probable age related degradation which was more pronounced at the Dispatch end. This link has been unrealiable and unused for several years due to tree probems interfering with the Path. The last few months this link has showed some returning connectivity indicating the possibility that the tree situation has improved. This effort to replace the aged Antenna System (Dish and Waveguide) on the worst tested side (Dispatch), along with some 40' of extra Height available on the Dispatch tower may buy back enough Signal level to re-enable the radios at that Site and readily improve coverage in and around the Blad Hill area. Regardless this replacement will not be a wasted effort even if it doesn't assure a stable link with the existing obsolete equipment (Alcatel MDR8000) as the Bald Site is likely to be a key player in any conceivable replacement System regardless of RF Band and technology employed (VHF/800MHz/etc).
